### 1. LA SIERRA COMMUNITY CENTER LEASE (Smith/Young)

Administrative Analyst Young made a recommendation to approve a five (5) year lease between the Carmichael RPD and MCS Preschool Inc dba Montessori Children's School; for exclusive tenancy in approximately 960 sq. ft. portion of property/footprint for a modular classroom/portable trailer with an additional 4,128 sq. ft. of shared outdoor space and approximately 3,711 sq. ft. of air conditioned exclusive building space, designated as Suite 170 with approximately 1,500 sq. ft. of asphalt space within the adjacent enclosed fenced area; for a term of five (5) years, December 1, 2018 to November 30, 2023; Monthly rental lease amount of \$5,434.26; authorize the District Administrator to sign the Agreement.
